Grace v. District of Columbia

The DC Circuit Court of Appeals invalidated the District's "good reason" CCW restriction.

The case will likely be appealed to the United States Supreme Court. The Supreme Court cannot possibly entertain all the appeals it receives. But one criterion for choosing to hear a case has been whether it is necessary to resolve a conflict among the Circuits. The Grace decision

has created such a conflict because other Courts of Appeal have upheld virtually identical CCW regimes in New Jersey, New York, Maryland and California.

On the other hand the Justices may feel that their membership is for now too much in flux for any decision they make on this issue to have any lasting effect.

This Black Friday the FBI fielded 203,086 background checks, up from the previous single-day highs of 185,713 last year and 185,345 in 2015. The two previous records also were recorded on Black Friday.

2018 Bass Derby

Two Best Bass Team Tournament Rules

- Sign in time will be 1 hour before start time.
- Boats will be released in the order in which they sign in.
- Late comers must find tournament director to sign in before fishing.
- Max 3 people fishing per boat; each must have a valid CA fishing license if over the age of 15.
- There must be at least one active member per boat.
- Guests over 21 are limited to 3 visits on the property. Your own children over 21 are limited to 3 visits per year.
- Live wells are mandatory.
- Dead fish will not be weighed.
- There will be a 10mph speed limit for the first ½ hour, and 30mph after that.
- Pre-fishing one day before the tournament is not allowed.
- Artificial baits only.
- 12" minimum length, measured on WIL-E-GO flat board.
- Please have required Coast Guard safety equipment on board.
