Fast & Furious

Another Fast & Furious firearm has turned up in Mexico, this time a .50 BMG in El Chapo's rumpus room.

The day before, a significant ruling came down in the Fast & Furious litigation. By now so many of our readers are too young to recall, that a brief recap is in order. Fifteen minutes before the House Oversight Committee's scheduled vote to hold former Attorney General Eric Holder in contempt for disregarding its subpoena of documents related to the administration's running guns to Mexican cartels, President Obama (despite his claim to know nothing of the operation other than what he had heard on the news) claimed executive privilege. The Committee held Mr. Holder in contempt anyway. Because Mr. Holder's Justice Department could not enforce the contempt, the Committee itself filed an enforcement action. On January 19th, U.S. District Court Judge Amy Berman Jackson denied the administration's claim of privilege. The administration will undoubtedly appeal the ruling but it must be disquieting for Messrs. Holder and Obama that Judge Jackson is an Obama appointee.
